

## Government subsidy for folding solar container in Finland

Which projects should be prioritized in the energy subsidy program?

In this case, priority is given to well-prepared projects that can cost-effectively promote the goals of the energy subsidy program and that are not estimated to have significant harmful environmental effects.

Do you get a tax subsidy if you invest in solar?

Companies and municipalities receive subsidies of 24 to 40 percent if they invest in photovoltaics. However, this subsidy does not apply to residential buildings and building societies. But the installation of solar systems on private homes is subject to tax advantages of up to 10 percent of the total investment.

How much funding is available for the Sustainable Growth Programme?
